

ELECTRIC VEHICLE INCENTIVES

Your guide to creating healthier communities and a healthier planet while saving money

U.S.

Will you owe federal taxes this year?

You may qualify for federal tax credits of up to \$7,500 depending on how much you owe and what kind of vehicle you buy.

Will you earn less than these amounts this year?

- \$150,000 for single filers
- \$204,000 for head-of-household
- \$300,000 for joint filers

You may be eligible for these state rebates:

- \$5,000 for hydrogen fuel cell vehicles (ex: Toyota Mirai)
- \$2,500 for all-battery electric vehicles (ex: Nissan Leaf)
- \$1,500 for plug-in hybrid electric vehicles (ex: Chevy Volt)
- \$900 for zero-emission motorcycles (ex: Zero)

Is your household income at or below the levels for low or moderate income?*

You may be eligible for an additional \$2,000 state rebate for hydrogen fuel cell vehicles, all-battery electric vehicles and plug-in hybrid electric vehicles.

Do you live in the San Joaquin Valley, Orange, Los Angeles, Riverside or San Bernardino counties? Is your household income at or below the levels defined for low, moderate or above moderate income?* Do you own an older vehicle that you want to trade in?

You may be eligible for up to \$9,500 in incentives to retire your old, high polluting vehicle and purchase a new or used conventional hybrid, plug-in hybrid electric vehicle or all-battery electric vehicle. Or instead receive vouchers for public transit.

Do you live in Alameda, Contra Costa, Santa Clara, Santa Cruz, Solano or San Francisco county? Is your household income at or below the levels defined for low, moderate or above moderate income?*

You may be eligible for low-interest loans and buy-downs to purchase a conventional hybrid vehicle, plug-in hybrid electric vehicle, all-battery electric vehicle or hydrogen fuel cell vehicle.

Do you live in Los Angeles or Sacramento?

In 2017, you may be eligible to participate in low-income electric vehicle carsharing programs in these two cities.

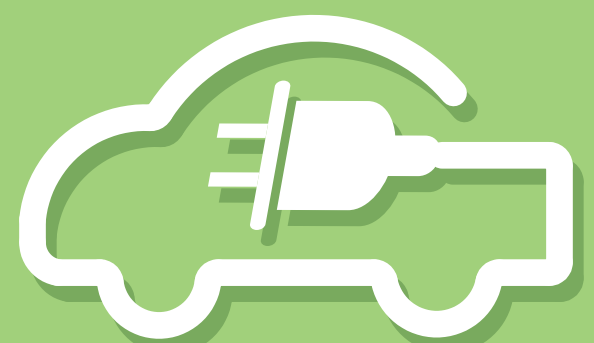
PERKS

- All Californians who purchase a plug-in hybrid, all-battery electric or hydrogen fuel cell vehicle are eligible for Clean Air Vehicle stickers. That means you can drive in the carpool lanes for free!
- Many of California's electricity utilities now offer rebates for electric vehicle charging stations in your home, apartment or place of work. Some also offer special electricity rates for electric vehicle charging.
- Many insurance companies also offer better rates for electric vehicles.
